## **B. Audit & Compliance Report**

#### **B.1 License Audit:**

The TrafficServer project's main license is the Apache Software License 2.0. Based on our audit of the code, the main license applies also to many of the sub-components of the product. We also identified several third party licenses (set out in Appendix 2) but these are all compatible with the main license.

In conclusion, our audit identified no legal risks in using or distributing TrafficServer.

#### Disclosure of source code

Source code is not required to be disclosed.

#### Distributing the component

When distributing Apache 2.0 licensed code, you need to (i) give a copy of the license to the recipients, (ii) mark any modifications to the original code, (iii) retain all notices in place, (iv) any notices included in a NOTICE file must be included in a readable form with the distribution

Any modified product can be licensed under a license different than Apache 2.0 as a whole, provided that the license's conditions are complied with with respect to the original code.
